

At this time, Gulf Shores School Board of Education President Kevin S. Corcoran announced graduation of the third class of seniors from the new Gulf Shores High School would be held tonight at 7:00 p.m. at the Wharf in Orange Beach, Alabama and invited everyone to attend.

Furthermore, Ms. Laura Eberly addressed the Mayor and Council to remind the Council and public about ADEM's Public Hearing set for May 19th beginning at 4:30 p.m. for questions and discussion and the Public Hearing beginning at 6:00 p.m. at the Civic Center regarding Baldwin County Sewer System's application to expand their waste water treatment plant down Fort Morgan Road. Ms. Rhonda Cavetta, speaking on behalf of her elderly parents who live in Lagoon Mobile Home Park adjacent to the Baldwin County Sewer System, expressed concern with what she felt was an illegally built sludge treatment pond that has been omitting a strong foul odor and which is effecting the health and enjoyment of the residents in that area. Mayor Robert Craft reported ADEM monitors the treatment plant and the City needs to make sure ADEM doesn't permit anything not allowed, further agreeing the upcoming ADEM Public Hearing was an important meeting that representatives from the City would attend as well to gather information and get questions answered. The Mayor also encouraged all to attend.

Mayor Robert Craft announced Legendary Marina & Yacht Club had scheduled their Groundbreaking Ceremony for Waterway West Village District One for Thursday, May 26<sup>th</sup> at 11:00 a.m. at the build site.
