Defendant further states that he knows that he is entitled to notice of the time and place of any future proceedings, as well as having been informed that any proceeding set by the Court he would be entitled to reasonable notice so that he could be present and present any evidence and be present in person should he decide to do so. The case in which the Defendant is involved is not a case punishable by death, and this request for the Court to act is made pursuant to RULE 9.1 of the Alabama Rules of Criminal Procedure, and pursuant to a Plea and sentencing agreement between the Defendant, PRO-SE, and the Municipality of Gulf Shores, Alabama, said recommendation is attached hereto as Exhibit "A".
